Zeiger /PEP will replace or repair without charge any product covered by this warranty which is returned to the dealer from which such product was purchased or to Zeiger/PEP and found to be defective. A defective product covered by this warranty will, at Zeiger/PEP's option, be replaced or repaired and returned to the customer. Zeiger/PEP are not responsible for charges or expenses for removal or reinstallation of any product covered by this warranty, or for shipping.

*We will have no obligation under this warranty for any product which:*

- *Has been improperly installed.*
- *Has been used in an installation other than as recommended in our installation or application guide instructions or specifications;*
- *Has failed or has been damaged due to an accident or misuse or alterations outside our factory;*
- *Has been repaired or modified by entities other than Zeiger Industries;*
- *Has been used with other product(s) which, in Zeiger Industries' opinion, are incompatible with the Zeiger product;*
- *Has been installed on commercial or rental vessels.*
